WHAT IS A VEHICLE RECALL?

RECALLS OCCUR WHEN A MOTOR VEHICLE OR ITEM OF VEHICLE EQUIPMENT (INCLUDING TIRES) HAS A **DEFECT** OR VIOLATES A FEDERAL MOTOR VEHICLE SAFETY STANDARD

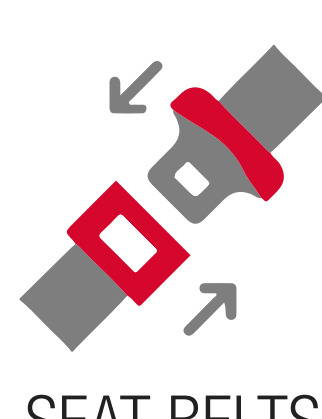

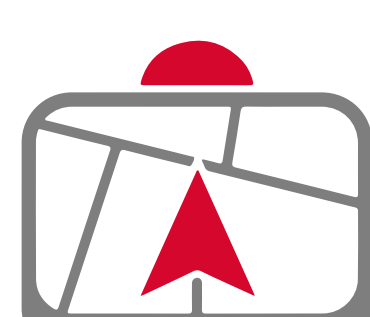

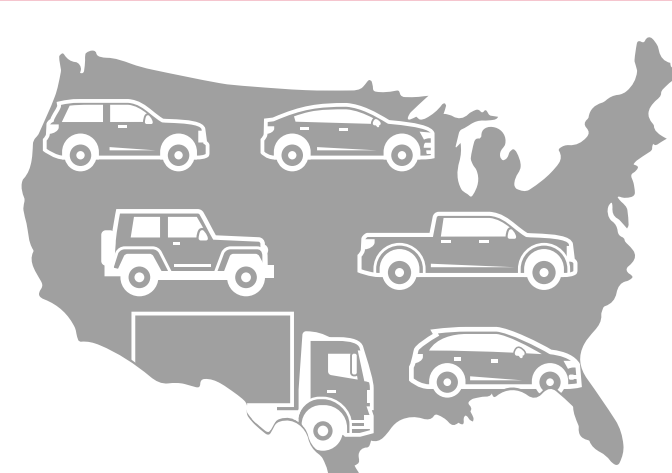
WHAT TO DO IF YOUR VEHICLE IS RECALLED

1 READ THE **RECALL LETTER** THAT YOU RECEIVED IN THE MAIL FROM THE MANUFACTURER



CONTACT YOUR **LOCAL DEALER** TO SET UP A REPAIR APPOINTMENT **2**

3 IF A DEFECTIVE VEHICLE CAUSED AN **INJURY**, CONTACT AN EXPERIENCED VEHICLE RECALL LAWYER



IN 2016, 53.2 MILLION

VEHICLES WERE AFFECTED BY VEHICLE SAFETY RECALLS IN THE UNITED STATES



FROM 2005 THROUGH 2013, NO MORE THAN **20.3 MILLION** VEHICLES WERE RECALLED IN A SINGLE YEAR

IN 2017, 63 MILLION RECALLED VEHICLES REMAIN ON THE ROADS IN THE UNITED STATES



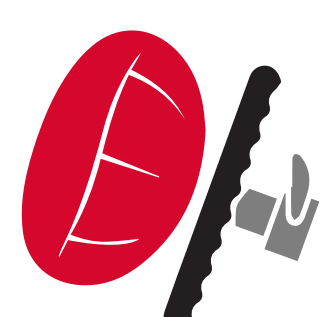
